QUESTAR BOARD DECLARES 237th CONSECUTIVE DIVIDEND WITHOUT A REDUCTION

SALT LAKE CITY — Questar Corp.'s (NYSE:STR) board of directors today approved a \$.205 (20.5 cent) quarterly common stock dividend. The dividend, payable March 15, 2004, to shareholders of record on Feb. 20, 2004, is the same as the previous quarter and two cents higher than a year earlier. This is the company's 237th consecutive dividend without a reduction.

Questar is an integrated natural gas company with \$4 billion in enterprise value. Headquartered in Salt Lake City, Questar engages in gas and oil development and production; gas gathering, processing and marketing; interstate gas transmission and storage; and retail gas distribution.
